Call for Abstracts

Texas Transplantation Society is pleased to invite the submission of scientific abstracts commencing February 8, 2012.

Submission Guidelines

- The abstract competition is open to all current and provisional resident/fellow members of Texas Transplantation Society. It is not mandatory for residents/fellows to be a member; however, non-member fellows must, in that event, be sponsored by a regular (Physician/Scientist) Texas Transplantation Society member.
- The abstract may consist of no more than 250 words, excluding title and references.
- The abstract should be submitted with your completed application form (see attached).
- There is no limit to the number of abstracts you may submit.
- Entries are submitted with the understanding that they represent work performed primarily by the author or the author's program and were not previously presented in a national meeting. This does not preclude subsequent presentation or publication in a peer-reviewed journal.
- Deadline for submission is Monday, May 7, 2012 via email.
- Entries must be sent electronically by emailing as a PDF or word document to:

- Winner will be reimbursed for their travel and hotel as follows: up to \$200 for round-trip travel (either air fare or mileage based on prevailing IRS rates); and one nights' stay at the host hotel at no charge (room and tax only).
- Winner will be notified by June 4, 2012.

All abstracts will be reviewed by the 2012 Program subcommittee; the committee has the right to make the final decision on which abstracts will be accepted; all abstracts accepted by the committee will be published in the meeting syllabus, which will be distributed on-site, as well as on the TTS website, author permitting.

Presenting authors of accepted abstracts are required to register for the TTS annual meeting before June 26, 2012. All travel arrangements and hotel reservations are the responsibility of the individual, not TTS.
